### YOUTH Girls Payment Options (2023-2024)

ALL FEES GO TOWARDS: TOURNAMENT FEES, POWER LEAGUES, OVERHEAD COSTS, AND COACHING SALARIES BUT ARE BASED ON NUMBER OF PLAYERS PER TEAM AND NUMBER OF TOURNAMENTS ATTENDED, AS SUCH, FEES ARE SUBJECT TO CHANGE. DOES NOT INCLUDE USAV, AAU, OR JVA NATIONAL TOURNAMENT FEES OR FAMILY'S TRAVEL COSTS. UNIFORMS WILL BE PURCHASED SEPARATELY.

#### Option A *(includes discount for upfront one-time payment)*

1. NON-REFUNDABLE **\$2,900** DUE WEDNESDAY, 7/19 (PAYMENTS RECEIVED AFTER 7/19 WILL NOT BE ELIGIBLE FOR DISCOUNT)
2. ONE-TIME PAYMENT IN FULL.
3. CASH, CREDIT VIA OASYS/WEBSITE, OR CHECK

#### Option B

1. NON-REFUNDABLE DEPOSIT OF **\$550** DUE WEDNESDAY, 7/19
2. **\$425** TO BE PAID BY THE 13<sup>TH</sup> OF EVERY MONTH FOR 6 MONTHS (OCT - MAR), FOR A TOTAL OF \$3,100
3. AUTO-DRAFT PAYMENT VIA OASYS/WEBSITE ONLY

#### Option C

1. NON-REFUNDABLE DEPOSIT OF **\$600** DUE WEDNESDAY, 7/19
2. **\$250** TO BE PAID BY THE 13<sup>TH</sup> OF EVERY MONTH FOR 10 MONTHS (OCT – JULY), FOR A TOTAL OF \$3,100.
3. AUTO-DRAFT PAYMENT VIA OASYS/WEBSITE ONLY
